

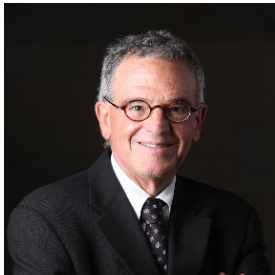

**Julie Hammerman** is inspired by the use of investment capital and business as a force for good in the world. As the ED of JLens, she oversees the organization’s educational, advocacy, and advisory services. Julie began her career in investment banking on Wall Street, and later served as an investment advisor at JP Morgan and Merrill Lynch. She was on the founding team of a for-profit social enterprise focused on women's health. Most recently Julie was the Impact Investment Strategist at a multi-family office. Julie received her MBA from Harvard Business School and her BA in Economics from Tufts University. She is a Wexner Jewish Heritage alum, an UpStart incubator graduate, and the proud recipient of the Jewish Community Relations Council’s 2018 Innovative Leadership Award.



**Dr. Stephen Freedman** is provost of Fordham University and professor of ecology and evolutionary biology. He earned his B.Sc. from Loyola of Montreal, his M.E.S. from York University in Toronto, and his Ph.D. from the University of California at Irvine. Dr. Freedman joined Loyola University of Chicago in 1978 and served as professor in the Department of Natural Science, member of the graduate faculty in the Department of Biology, and dean of Mundelein College. He became academic vice president at Gonzaga University in 2002 and joined Fordham in 2007 as senior vice president and chief academic officer. In October 2010, his position was elevated to provost. Dr. Freedman chairs the conference of chief academic officers of the Association of Jesuit Colleges and Universities.



**Dr. Janice Weinman Shorenstein** is ED/CEO of Hadassah, the Women’s Zionist Organization of America, Inc. (HWZOA), comprised of 330,000 members, donors and supporters with nearly 900 chapters around the United States. HWZOA owns the Hadassah Medical Organization in Israel and offers programs on healthcare, leadership development and advocacy in the U.S. Previously, Weinman was President, Kids in Distressed Situations, Inc. (K.I.D.S.); Corporate VP for External Affairs, Mount Sinai-N.Y.U. Medical Center; Asst. to the U.S. Secretary of Education during the Clinton Administration, ED, the American Association of University Women, EVP, the College Board, and Chairperson, the Women’s Leadership Board, John F. Kennedy School of Government at Harvard University. She received her Masters and Doctoral degrees from the Harvard Graduate School of Education.

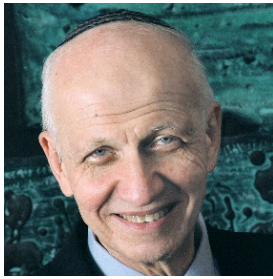


**Beth Mann** is VP, Institutional Advancement, of the Jewish Federations of North America. In this role, Beth is responsible for the development and implementation of a corporate and philanthropic sponsorship strategy, bringing resources and support to national programs and services, as well as local federation needs. Nigel has twice been named a member of the Forward 50, and is a recipient of the Bernard Reisman Award. In 2015 he was awarded an honorary doctorate by the Jewish Theological Seminary. Before founding Hazon, Nigel was a professional fund manager in London, where he worked for NM Rothschild and was co-head of UK Equities at Govett. He has an MA in History from Georgetown, and has learned at Pardes, Yakar, and the Hebrew University.

## 9:30-10:15am Rabbinic Insights on Investment and Business as a Force for Good



**Rabbi Irving (Yitz) Greenberg** is a leading Jewish thinker and activist who has written extensively on Jewish theology after the Holocaust, the ethics of power, Jewish Christian relations, and religious and cultural pluralism. He has served in the Orthodox Rabbinate, in academia (City University of New York), and Jewish Communal Life (Founding President, CLAL: The National Jewish Center for Learning and Leadership; Founding President Jewish Life Network/Steinhardt Foundation). He is a pioneer in Holocaust education and commemoration as well as in the Jewish Christian dialogue which sought to revise theology in light of the Shoah. He has written *The Jewish Way, Living in the Image of God, For the Sake of Heaven and Earth: The New Encounter of Judaism and Christianity*, *Sage Advice: A New Commentary on Pirkei Avot*, and numerous monographs and articles.



**Rabbi Julie Schonfeld** is the Chief Executive Officer of the Rabbinical Assembly (RA), the international membership association of Conservative/ Masorti rabbis. Rabbi Schonfeld served on President Obama's White House Council for Faith-Based and Neighborhood Partnerships. Newsweek named her one of the 50 most influential Rabbis in America in 2011, 2012 and 2013. She was named by Jewish Women International as a "Woman to Watch" in 2011 and has also been named in the Forward 50. Rabbi Schonfeld is often called upon to represent the Jewish community in national and international settings and is known for her incisive application of Jewish thinking to world events.



**Rabbi Aaron Panken, Ph.D.**, is President of Hebrew Union College-Jewish Institute (HUC-JIR), North America's premier institution of Jewish higher education and the center for professional leadership development of Reform Judaism. Ordained at HUC-JIR in 1991, Rabbi Panken has taught Rabbinic and Second Temple Literature at the College-Institute since 1995. His previous roles at HUC-JIR include Vice President for Strategic Initiatives as well as Dean and Dean of Students at the New York campus. He has taught for the Wexner Foundation, the Hartman Institute, and in numerous multi-denominational settings. He earned his doctorate in Hebrew and Judaic Studies at NYU, where his research focused on legal change in Rabbinic Literature. Prior to teaching at HUC-JIR, he served congregations including Congregation Rodeph Sholom in New York City and Westchester Reform Temple in Scarsdale, NY.



**Rabbi Jacob Siegel** oversees JLens' Jewish communal engagement and education, and assists with shareholder advocacy and interfaith investor collaborations. He has served as a dynamic educator on the topics of money, social justice, sustainability, and ethical food for Hazon, Eden Village Camp, The 92nd Street Y, Jewish Farm School, and at colleges and synagogues. Rabbi Siegel fought poverty and racism in his prior role with Americorps, and he founded a nonprofit focused on youth and violence prevention. Rabbi Siegel received his rabbinic ordination from Yeshivat Chovevei Torah, a modern Orthodox rabbinical school in New York, his undergraduate degree in Mathematics from Washington University in St. Louis, and he spent a year at Israel's Pardes Institute.

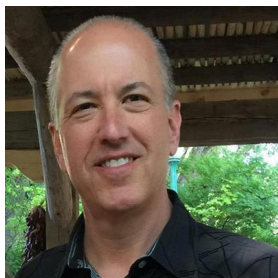

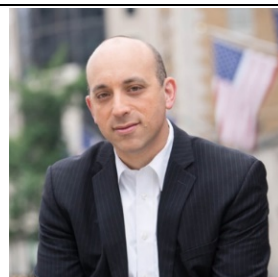
**Sir Ronald Cohen** is a preeminent international philanthropist, venture capitalist, private equity investor, social innovator, and vanguard of the global impact investing revolution. He was co-founder and Executive Chairman of Apax Partners Worldwide LLC, and has chaired numerous global initiatives on impact investment. Today, he is the Chairman of the Global Steering Group on Impact Investing (GSG) which followed the G8 Social Impact Investment Task Force, which he led, Chairman and co-Founder of The Portland Trust, co-founder of Social Finance UK, US, and Israel, and co-founder of Bridges Fund Management UK and US, and Bridges Ventures Israel. The Alliance works to increase awareness of impact investing in the US, foster deployment of and demand for impact capital across asset classes globally, and partner with stakeholders, including government, to build the impact investing ecosystem. 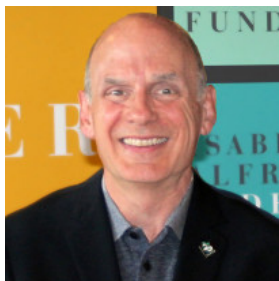

**Vanessa Bartram.** Vanessa is an impact entrepreneur turned impact investor. She is Managing Partner of ZORA, a Tel-Aviv based impact investment fund supporting Israeli entrepreneurs with scalable solutions to health, education, poverty and environmental challenges. Vanessa is Founding Board Member of LAVAN, a network of impact investors guided by Jewish learning, and launched B Lab Israel, the local affiliate of B Lab, the world's leading movement of companies harnessing the power of business for good. In 2008, Vanessa founded WorkSquare, a Miami-based recruiting firm designed to improve financial outcomes for low-income workers. Vanessa started her career in investment banking with KPMG Corporate Finance in Mexico City. She holds an MBA from Harvard, a BA from Princeton, and is a Wexner Foundation Heritage Fellow.



**Shlomi Zidky** is a director and one of the founding members of Social Finance Israel (SFI). SFI is a social-financial intermediary, devoted to developing and implementing innovative social financial tools, such as Social Impact Bonds (SIBs). Shlomi began his career as a consultant and project manager for business consulting companies. Later he served as a senior consultant to the Minister of in Israel. Prior to joining SFI, Shlomi was the CEO and Co-founder of Israel's Hope, an NGO aimed to promote change in Israel's electoral and government system. Shlomi holds an M.A. in Public Policy from Tel Aviv University, an M.A. in Economics and a B.A. in Economics and Business Administration from Bar Ilan University. In addition, he works as a teaching assistant in the Public policy department at Tel Aviv University.



**Eve Rubinstein** is US Director of Israel Venture Network-IVN. In recognition of his contributions to the advancement of the social business sector, Allan received the 2017 Midot Social Action Award. Allan has a B.Sc in Computer Science from the Technion, and an MBA from the international Kellogg-Recanati Program.



**Cecile Biliou** is the Founder and Managing Partner at Impact First Investments, Israel's first impact venture fund. Cecile specializes in merging technology, profit and social impact and is a pioneer of the impact investing industry in Israel. Prior to founding Impact First, Cecile managed the Noaber Foundation's Israeli investments for over 14 years, and has extensive hands-on management experience with high-tech start-ups. She was one of the initiators of the Al-Bawader private equity fund, established to invest in businesses in the Arab community in Israel. Prior to her professional career, Cecile served as an intelligence officer in the Israel Defense Forces. Cecile studied at the Hebrew University of Jerusalem.



**Calanit Valfer** is Managing Partner and co-founder of the Elah Fund, a growth capital impact fund investing in high potential, medium sized, export oriented, low- and mid-tech companies in Israel's Negev and Galilee regions. The Elah Fund's expert team, access to superior deal flow and disciplined investment strategy aims to maximize financial returns to investors as well as generate measurable ESG improvements and positive impact for Israel.



**Dalia Black** is an advisor to foundations, federations and families who seek to create and implement social impact investment strategies in Israel. Dalia's clients include the UJIA, UK's largest Jewish charity supporting Israel, whose Si3 initiative leverages impact investments in Israel to increase Israel engagement and scale of impact. Dalia built her career in the financial sector having been Vice President at the Delek Group, a TA25 listed company. Previously, Dalia managed investments and fund raising at Viola Credit, Israel's largest venture lending fund, and was a Management Consultant for Accenture based in London. In a voluntary capacity, Dalia is the co-founder of a Tel Aviv NGO that established a school promoting Jewish studies in a pluralist environment for religious and secular children.



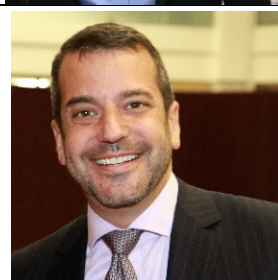
**Yosef I. Abramowitz**, an American-Israeli human rights activist, educator and entrepreneur is recognized as one of the pioneers of the solar energy industry in both Israel and East Africa. Named by CNN as one of the six top global "Green Pioneers," by PV Tech as "one of the most inspiring solar CEOs" worldwide, and as Person of the Year by the Israel National Business and Energy Conference, Abramowitz is co-founder of the Arava Power Company, Israel's leading solar developer. Nominated three times for the Nobel Peace Prize, Abramowitz heads Energiya Global Capital, an impact investment platform that provides healthy returns to investors while advancing the environmental and humanitarian goals of providing affordable green power to underserved populations as a fundamental human right.

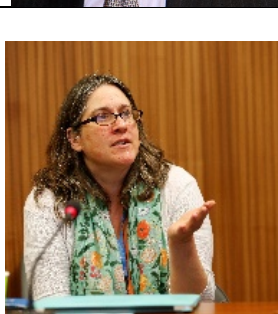

**Itai Nixon** is the director of economic affairs at the Ministry of Strategic Affairs and Public Diplomacy. Prior to his work in the Ministry, Itai worked as an economic consultant. Itai received his bachelor's degree from The Integrative Program: Philosophy, Economics, Political Science (PEP) at The Hebrew University of Jerusalem, and his Masters in Public Policy from Georgetown Public Policy Institute (today the McCourt School of Public Policy at Georgetown University). 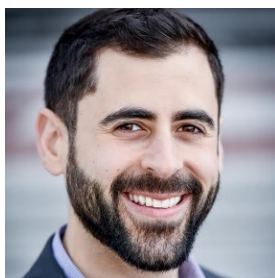

**Rabbi Joshua Ratner** oversees JLens’ advocacy in the corporate and investment arena on social, environmental, and Israel-related concerns. He previously served as the director of the Jewish Community Relations Council in Connecticut, the Associate Rabbi at Yale University, and the Rabbi at Congregation Kol Ami. Rabbi Ratner is a board member of the Jewish sustainability organization Hazon, a Global Justice Fellow with American Jewish World Service, and a Rabbinic Fellow of CLAL’s Rabbis Without Borders program. His writings about the interplay between Judaism and contemporary topics have been featured on Huffington Post, myjewishlearning.com, and other periodicals. Rabbi Ratner was ordained by the Jewish Theological Seminary, and is a graduate of Columbia University and Columbia Law School. He was a corporate attorney before entering rabbinical school.



**Laura Campos.** As director of the Nathan Cummings Foundation's Corporate & Political Accountability program, Laura employs both grant making and active ownership strategies to address the ways in which corporations can both advance and hinder progress on climate change and inequality. She has led several large-scale projects on environmental and social risks and opportunities, as well as adherence to globally accepted ethical standards. 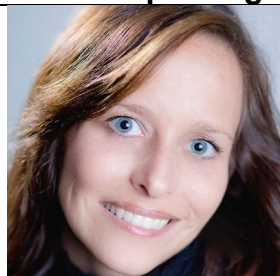

In the past four years, he coordinated the 2015 OurVoices campaign mobilizing religious support globally for COP 21, led organizing of faith communities for the People's Climate Marches, helped lead the faith-based fossil fuel divestment movement, supported the launch of the global Interfaith Rainforest Initiative, and co-founded Shine, a faith-philanthropy- NGO campaign to end energy poverty with renewable energy by 2030. He helps lead GreenFaith's new local organizing initiative, creating multi-faith GreenFaith Circles in local communities globally.

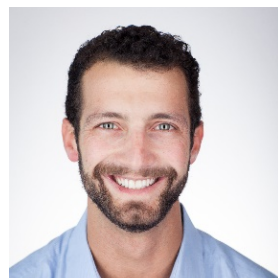
